### FROM THE FIRST SELECTMAN'S OFFICE—Cathy Osten

I want to take this opportunity to thank everyone for voting in this past election—we had a great turnout, and I'm very pleased to be invited back and serve as your First Selectman, along with Buddy Meadows and Michael Collins, for another two years.

I hope everyone had a great Thanksgiving. As usual, we're all looking forward to the Christmas season here at Town Hall—all three villages do a wonderful job of decorating for the holidays. And of course the Veteran's Memorial Park will have its usual lighted trees and gazebo. The Recreation Committee is preparing for some caroling this year, as are the Senior Center Smilers, who go caroling in area nursing homes.

Some of you might have seen the RFP in the paper for reconstruction of the main reservoir dam—we're on our way to the next step in re-activating the Baltic Reservoir, and hope to have a contractor on board by late this month.

Last month we finished all the sidewalk repairs left on the "punch list," and our capital improvement plan is targeting upper High Street to receive sidewalks and drainage repairs. We've also started working on revising the Town's Strategic Plan, building off the accomplishments of the last Plan and making some five-year projections that include not only the areas of economic development but ways in which we can expand human services programs, public safety initiatives, conservation, preservation, public/private partnerships, quality of life issues, etc.

I feel blessed to be part of our big family in Sprague; I wish you all a safe and happy holiday season.

**FEMA:** The Federal Emergency Management Agency (FEMA) is updating all flood zone maps. A copy of the zone map for Sprague is available in the town hall for viewing; residents are welcome to stop by and review whether or not their property is located within a flood zone. Residents might want to consider whether they need flood insurance, before changes are made by FEMA.

VETERAN'S DAY: On Veteran's Day, Wednesday, November 11, a flag folding ceremony was held as was a wreath laying cere-

### PLANNING AND ZONING COMMISSION COMPLETES ZONING REVISIONS

On October 14, 2009, the Planning and Zoning Commission unanimously approved the final phase of revisions to its zoning regulations. The action by the Commission that evening created four distinct village zones. Two of these zones separate Baltic village from the newly created Economic Development Zone, the site of the former Baltic Mill. The other two zones are in Hanover and in Versailles. The village zone regulations are intended to relax some of the regulations that have existed for a number of years. They are designed to encourage mixed use development. In the Economic Development Zone particularly, the regulations allow the commission more flexibility when working with the applicant. This final phase was the culmination of work that began in 2004. At that time the Commission started work on the Plan of Conservation and Development (PoCD). A PoCD is required by the State of Connecticut, and presents a Commission's recommendations for conservation and development of the town. When enacting zoning regulations, the Commission must show that the regulations are consistent with the PoCD. Revision of the PoCD was completed in 2007. Since that time, following those recommendations, the Commission enacted regulations that affect the use of nearly all property in Sprague. Some of those changes are conservation subdivision regulations, watercourse protection regulations, an increase in residential lot size requirements, and most recently, village zones. These changes are reflected on a zoning map, which together with the regulations is referred to as the "Comprehensive Plan of Development." The regulations and map are on file in the Office of the Town Clerk in the Town Hall. The recent regulation changes, which took effect November 4, 2009, are being added to the existing regulations, which will also be accessible at the Town's website.

I would also like to thank Chris Mueller for joining us as an alternate on the Conservation Commission. ### Branching Out... Notes from the Tree

I attended a Connecticut Tree Warden Association training session recently that focused on the aftermath and massive clean up operations following the tornado that struck Wethersfield in June of this year. The amount of damage that an F1 (lowest grade) tornado path a quarter of a mile wide and half a mile long caused is amazing! This training pertained specifically to the trees and damage from trees. Some of the interesting statistics:

350 trees were destroyed or heavily damaged (requiring removal)

35 homes were damaged by trees falling on or through them; most had repairable roof damage, a few had significant structural damage and one had to be razed (the tree was laying on the first floor on the  $2\frac{1}{2}$  story home!)

80% of the power outages were caused by trees

Only about 10% (35) of the trees that were damaged/destroyed were public trees The 10 or so huge trees on the town green were totally uprooted, yet the lawn on the possibility of appointing a new charter com- the green showed no evidence of a tornado going through,

> One logging company and several tree service companies worked 16 hours a day for over two weeks to remove trees and branches from the town.

> It is important for property owners to take a good look at their yards/properties and assess the potential damage a tornado or hurricane could cause to their homes. A good assessment may require hiring a tree service to evaluate and then correct problems. Tree work can be expensive, but less than home restoration or replace-

No one wants to believe a tornado could strike their town – but Wethersfield is proof that it can happen in Connecticut.

I survey town roads and the right-of-way public as often as possible but still rely on the Town road crew and the townspeople to inform me of any potentially hazardous trees to prune or remove. Information can be provided to town hall, the First Selectman or myself.

Thank you to the Sprague Garden Club for the opportunity to address them about Tree Warden responsibilities.

### TOWN OF SPRAGUE LEGAL NOTICE

The following Ordinances were adopted at a Special Town Meeting of the Town of Sprague held on November 17, 2009:

Ordinance #2009-1 – Tax exemption for farm machinery and farm buildings exemption pursuant to Connecticut General Statute's section 12-91. This ordinance creates exceptions, upon application and the meeting of criteria set forth in the General Statutes, for farming real and personal property tax assessments. This ordinance shall be applicable to the October 1, 2009 Grand List and be effective thirty (30) days after publication.

### Ordinance #2009-2 – Peddlers & Soliciting.

This ordinance regulates peddlers and solicitors, and requires those involved in these activities to obtain licenses by application and the payment of fees. The ordinance replaces an earlier ordinance, and shall become effective thirty (30) days after publication.

Ordinance #2009-3 – Regulating building and maintenance of approaches to any street or highway in the Town of Sprague. This ordinance modifies an existing ordinance regulating access and egress to public streets. This ordinance shall become effective thirty (30) days after publication.

Copies of said ordinances may be inspected during normal business hours at the Sprague Town Clerk's Office, and are also available upon request.

Those of you who are required to complete Community Service hours are welcome to come! We can use the help.


Besides, it's a lot of fun, with great storytelling, swapping of recipes and hearing about the history of the town.
